It's Trendy to Visualize Convolution with GNU C-Graph

[Boston, Massachusetts - 11, Sept 2013] <u>GNU Project</u> system administrators have now recorded 1,277 downloads since their convolution demo package "<u>C-Graph</u>" was released two years ago. With over 150 GNU download mirror sites worldwide, and its inclusion in the <u>Fedora</u> GNU/Linux distribution, a userbase of 100,000 is a conservative estimate. C-Graph (short for "Convolution Graph) demonstrates what is regarded as the most significant theorem in signal processing, the <u>Convolution Theorem</u>. This <u>free software</u> package is set to become a popular tool for lecture demonstrations and lab work in universities and colleges.

Convolution

<u>Convolution</u> is a mathematical description of the response of what engineers refer to as a "<u>linear</u> <u>time-invariant system</u>" to an input signal. Practical examples of this natural phenomenon abound: reverberation in music production is the convolution of sound with echoes from surrounding objects; a blurred photograph is the convolution of the ideally sharp image with a function defined by the camera lens. Convolution theory has applications that range from <u>computer vision</u> to <u>statistics</u>.

Signals have dual descriptions: the time domain, and the frequency domain. An operation called the <u>Fourier Transform</u> gives the signal spectrum, the representation of a time function in the frequency domain. According to the Convolution Theorem, the Fourier transform of the convolution of two signals is equal to the product of their Fourier transforms. The converse is also true - the inverse Fourier transform of the product of the signal transforms is equal to their convolution.

Because of its periodic nature, the <u>Fast Fourier Transform</u> or FFT (the high-speed computational analogue of the Fourier transform) results in circular convolution, a distortion of the naturally occurring linear convolution endemic to the time domain. GNU C-Graph demonstrates the criterion under which linear and circular convolution produce the same result. This understanding is fundamental to the design of filters in the many applications, today, that rely on convolution theory. Features

C-Graph is user-friendly, its interactive dialogue dispensing with the learning curve for writing code. The package features a scalable wave set consisting of pulses, their periodic counterparts, and aperiodic functions. Effective displays of the signals, their spectra, and their convolutions can be mounted with just a few keystrokes.

The interactive dialogue prompts the users to choose two signals from a wave set of sine, cosine, triangular, rectangular, sawtooth, exponential, ramp and step functions. On selecting the length of the signals, their frequencies or pulse widths (if applicable), and scale factors, C-Graph then displays the waveforms, their spectra, and a comparison of their linear and circular convolutions. The graphs displayed are automatically saved for further analysis and/or printing. About GNU C-Graph

C-Graph is coded in Fortran and runs on any GNU/Linux system. The package is derived from the electrical engineering BSc dissertation "Interactive Computer Package Demonstrating: Sampling Convolution and the FFT", Adrienne Gaye Thompson, University of Aberdeen (1983). About the GNU Operating System and Linux

Richard Stallman announced in September 1983 the plan to develop a free software Unix-like operating system called GNU. GNU is the only operating system developed specifically for the sake of users' freedom. See http://www.gnu.org/gnu/the-gnu-project.html.

In 1992, the essential components of GNU were complete, except for one, the kernel. When in 1992 the kernel Linux was re-released under the GNU GPL, making it free software, the combination of GNU and Linux formed a complete free operating system, which made it possible for the first time to run a PC without non-free software.
