conveps takes one required argument, the filename without extension of the Encapsulated PostScript (EPS) files. This argument can be followed by one or two numbers indicating the first and last EPS files that should be processed. The defaults for the first and last files are 0 and 100, respectively. If these arguments aren't used, and  $\langle filename \rangle$ . 0 doesn't exist, conveps tries to process  $\langle filename \rangle$ . 1. If a file fails to exist for a larger number, conveps will exit.

Given the files 3DLDFmp.1, 3DLDFmp.2, and 3DLDFmp.3, "conveps 3DLDFmp 1 3" will generate the files 3DLDFmp\_1.pnm, 3DLDFmp\_2.pnm, and 3DLDFmp\_3.pnm.

conveps can be invoked using the options in the following list. Options can take no argument, a required argument, or an optional argument. Optional arguments must be passed as follows:  $--\langle option\rangle = \langle argument\rangle$ . Required arguments can be passed like this, but in this case, a space can be substituted for the equals sign.

#### 0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondarily, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of "copyleft", which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does.
